Hours are set by seniority shift bid per the labor agreement. Shifts may include one weekend day; successful candidate must be available to work a set day, swing, or graveyard shift.

MINIMUM REQUIREMENTS:

- Oregon State General Journeyman license is preferred; or a minimum of Journeyman Manufacturing Plant Electrical license is required.
- Experience working in a commercial or industrial environment is preferred.
- Electronic schooling in controllers, data-gathering, and solid state controls is preferred.
- Course work in technical electronics: solid state and oscilloscope training, high voltage systems and related equipment, all electronic systems, mercury vapor, sodium H.I.D. lighting systems and their transformers, and interpretation of schematics and technical manuals is preferred.
- Familiarity with electrical distribution systems with voltage up to 12.5 kv is preferred.
- Experience with computers and PLC's for trouble shooting and adjusting is preferred.
- Class B Commercial Driver's License with Air Brake endorsement at time of hire is preferred; or, the ability to obtain one within the six-month probationary period is required.
- Ability to obtain and maintain security clearance for unescorted access to secured areas of the airport is required.

SKILLS AND ABILITIES:

- Demonstrated ability to read and comprehend technical manuals and prints.
- Must be able to exercise good judgment in the absence of specific direction.
- Willing to demonstrate the Port's commitment of valuing differences among individuals and passion for being inclusive.
- Comfortable with work in tight spaces and at heights.
- Proven ability to follow instructions and meet deadlines in a fast paced working environment.
- Able to work independently, with little or no supervision.
- Strong communication skills; both orally and in writing.
- Work cooperatively with internal and external customers.
- Skilled at troubleshooting and problem solving electrical issues.
- Willing to promoting safety as a guiding principle and a regular practice in accomplishing work.
- Proven team player who shows the utmost respect for others.
