We are looking for an outgoing team player who can develop and deploy enterprise business intelligence reporting to provide insights to Port staff, key Port partners, stakeholders, media, and the public on issues critical to the organization. The successful candidate will exhibit a strong sense of team-orientation, be highly collaborative, and will embrace the value and importance of service. This person will share our deep commitment to diversity, equity and inclusion and support performance measurement activities to ensure the Port is meeting its equity and strategic goals.

  - Make performance data and statistics more accessible to the public and other stakeholders by developing and publishing visual and interactive open data reporting.
- Strengthen the Port's data culture by providing leadership to internal communities of data and analytics practitioners across a variety of subject matters and technical areas.
