- Utilize a full range of tools, shop equipment, and diagnostic devices to maintain, diagnose, overhaul, and repair:
  - Ignition systems;
  - Carburetor and fuel injection systems;
  - Electrical systems;
  - Alternative Fuel Systems including CNG and Propane;
  - Mechanical, hydraulic, and pneumatic brake systems;
  - Automatic and standard transmissions and drive trains, including Power take offs (PTOs);
  - Suspension and steering systems, including hydraulic and pneumatic;
  - · Heating, cooling, and exhaust systems;
  - Full range of small and large gasoline and diesel engines;
  - Hydraulic and hydrostatic systems; and
  - · Automotive computer sensor systems.
- ARC, MIG, TIG, and gas welding/brazing for repairs and fabrication of one-off parts.

- Minimum of five (5) years of experience in the diagnosis, maintenance, overhaul, and repair
  of full range of light and heavy equipment and vehicles; or, certification from an accredited
  automotive/diesel technician training program and three years of relevant work experience is
  required.
- Experience with maintenance and repair of emergency vehicles is preferred.
- · Transit bus repair and maintenance is preferred.
- Working knowledge of basic gas and arc welding and brazing techniques is required.
- Valid driver's license is required. Class A Commercial Driver's License with Air Brake, Tanker, Combination and Passenger endorsements is preferred at time of hire; or the ability to obtain within the 6-month probationary period is required.
- Working knowledge of and experience with specialized electronic diagnostic systems (eg. Snap-On MODIS, Cummins Insite, Thermoking) is preferred.
- Emergency Vehicle Technician (EVT) Certification is preferred.
- Automotive Service Excellence (ASE) Certification is preferred.
- Ability to obtain and maintain security clearance for unescorted access to secured areas of the airport is required.
